NOTICE OF VIOLATION

RE: Sewage overflow; pollution of ground surface at 8447 ROLLING RIDGE COURT, ELLICOTT CITY, MD 21742

Dear Owner:

On <u>October 17th 2018</u> a site investigation was conducted at <u>8447 Rolling Ridge Court in Ellicott City, MD, postal code 21742.</u> At the time of investigation the septic tank was observed to be actively overflowing at the broken cleanout by the house and discharging raw sewage into the yard. At the time of investigation we were able to conclude that the onsite sewage disposal system serving the house at <u>8447 Rolling Ridge Court</u> was the source of the sewage effluent at the surface of the ground.

Be advised that the condition of sewage effluent emerging onto the soil surface is a violation of the Code of Maryland (COMAR) 26.04.02.02(E): "A person may not dispose of sewage, body, or industrial wastes in any manner which may cause pollution of the ground surface, the waters of the State, or create a nuisance." This condition is also in violation of the Howard County Code 3.804(a)(1), as a sewage overflow is defined as a nuisance, [12.110(a)]. It is the property owner's responsibility to maintain the onsite sewage disposal system so that an overflow does not occur until a repair can be performed.

You are hereby ordered to immediately pump and haul the contents of the sewage disposal system and treat the contaminated soil with hydrated lime. You will be responsible for continuing to pump the contents of the system at a frequency that prevents sewage effluent from coming to the ground surface. Furthermore, you must apply for a septic permit within 7 (seven) days and install within 14 (fourteen) days of receiving this notice. Failure to comply will result in the issuance of a civil citation(s). Under Howard County Code, paragraph 12.112, each day this violation is allowed to occur is considered a separate offense.

If you believe that the condition described above is not and could not be a hazard to health, or that the Health Department is not acting in compliance with pertinent laws and regulations, you may request a formal hearing before the Board of Health within 15 (fifteen) days of receipt






