15036 Scottswood Court, Woodbine, Maryland 21797

Dear Mr. and Mrs. Haney:

On June 26, 2008, you applied for a permit to install a propane tank that you had already installed at your residence without a permit. Further review of the issue by the Health Department revealed that the tank was installed without meeting the required setbacks. This is a violation of both Code of Maryland (COMAR) and Howard County Code. A variance request was received on September 10, 2008, requesting to locate the underground propane tank less than 100 feet from the existing well. The request was denied on September 22, 2008 by Michael J. Davis, R.S., Assistant Director, of the Bureau of Environmental Health. You were informed at that time that the propane tank would have to be removed. More than adequate time has been allowed for this task to be accomplished.

Instillation of the propane tank violated Howard County Code 3.901(F) which requires submittal of a Site Plan that includes well and septic locations, as well as existing and proposed structures, prior to approval of a Building Permit. Be advised that the propane tank installed continues to be in violation.

You must provide evidence that the violation has been remedied within 15 (fifteen) days of receipt of this notice. Failure to comply will result in the issuance of a civil citation(s). Under
