- D. On applications for wells for potable water supplies or for dairy farms, the most probable source or sources of drilling water (up to three) shall be listed.
- .05 Approval of Applications for Wells for Public and Individual Potable Water Supplies and for Dairy Farms.
  - A. Application Review.
- (1) A well construction permit application for an individual potable water supply shall be submitted to the Approving Authority for review. An application for a well which is to supply water for a public water system shall be submitted to the Approving Authority only through the Department of the Environment, or for use on a dairy farm through the Department of Health and Mental Hygiene.
  - (2) The Approving Authority shall approve the application if:
    - (a) The proposed well meets the criteria of §B; and
- (b) The proposed source or sources of drilling water meets the requirements of Regulation .07C.
- (3) If it approves the application, the Approving Authority shall sign it on a space provided.
  - (4) A disapproved application shall be returned to the applicant.
  - B. Criteria for Approval.
- (1) A proposed well construction shall be in accordance with the applicable Master Water and Sewer Plan, promulgated in accordance with Environment Article, Title 9, Subtitle 5, Annotated Code of Maryland.
  - (2) Siting.
- (a) A proposed well location shall satisfy the following minimum distance requirements:
- (i) 10 feet from a property line, to allow access to the well without encroaching on adjoining properties.
  - (ii) 15 feet from a road or dedicated road right-of-way.
- (iii) 30 feet from a building foundation, for the purpose of protecting the well from a foundation or soil treated to control pests, insects, or vermin. A distance less than 30 feet may be considered in replacement of a well serving a lot which does not meet minimum lot ownership as defined in COMAR 26.04.03.
