This is to advise that the Howard County Health Department recommends issuance of the demolition permit for the above referenced property.

By accepting this recommendation, the builder agrees with the following conditions set forth by the Health Department:

- The existing septic system has been disconnected and abandoned by Fogle's Septic on May 13, 2011.
- Percolation testing must occur prior to any building permit approvals. A percolation testing application along with the appropriate fee(s) must be submitted prior to building permit stage.
- A Percolation Certification Plan will be required (*Howard County Code Sec. 3.805*) prior to any future building permits for this lot. The purpose of this plan is to establish an area designated for your initial septic system and two future repair systems.
- Before demolition, the well that serves the current house must be properly maintained which may include protective devices placed around it to prevent any damage during demolition. These precautions should remain in place during the demolition process.
- If the existing well is to be utilized by the new dwelling, it must be inspected by our office for compliance per COMAR 26.04.04.07 which includes sitting. Potability testing must occur for any use & occupancy.

If you intend to proceed with demolition of the existing house, you agree to and understand the conditions mentioned above and the risks that you will undergo on this property once demolition takes place.

If any problems/questions arise during any part of this process, please do not hesitate to call me at 410-313-2645. If any other wells are found on-site during demolition, you <u>must</u> notify this office immediately.
