



Percolation Test Report; 14430 Triadelphia Mill Road, Clarksville, MD 21029

Percolation tests were conducted at 14430 Triadelphia Mill Road, Clarksville, MD 21029 on June 16, 2021. Tests and profile descriptions were documented for 6 locations. Test holes 1, 2, 3A, 4 and 5 passed while test hole 3 had too much clay.

All percolation tests conducted were standard tests, measuring rate of fall for a pre-wet period followed by measurement and recordation of the time required for the water level to drop 1 inch. Areas that may be included in the septic reserve area are represented by test locations having satisfactory soil condition. The area must be at least 10,000 square feet and large enough to accommodate 3 systems for the planned residence.

The next step in the process is to have an engineer submit a percolation certification plan to confirm the design of the septic reserve area.



The following comments pertain to the review of the perc test plan for 14430 Triadelphia Mill Road.

1.) Add address #14430 to plan

- 2.) House box must be a suitable dimension of at least 55' x 70'
- · 3.) Well box must be at least 30 feet from house foundation and walkout
 - 4.) Well box must be at least 1500 sq. ft.
 - 5.) Well box/well must be at least 100 feet from any infiltrative stormwater device such as a drywell.
 - 6.) Add sq. footage to SDA and elevations next to each test hole.
 - 7.) Adjust proposed SDA so that the neighboring downgrade well located on 14440 Triadelphia Mill Road isn't within 45 degrees of it.
 - 8.) Field locate well on 14440 Triadelphia Mill Road
 - 9.) Add the word "well" to legend symbol so it reads, proposed well zone 1500 sq. ft.

As soon as I receive a revised plan, I will look it over and provide you with some potential test dates.
