

Dear Mr. Shpak:

A Notice of Violation was mailed to you on September 26, 1996 and a Second Notice was mailed to you on November 19, 1997 reporting observations of an overflowing septic system at the above referenced address and requiring connection to public sewerage. Those Notices also requested interim pumping of the septic tank with sufficient frequency to prevent additional discharges until connection is complete.

Due to continued observations of sewage discharges, a citation (copy enclosed) was issued to you on January 9, 1998 and sent by certified mail to your post office box. On or about January 20, 1998, via telephone, I explained the details of the citation to your secretary. Despite this explanation, the citation was subsequently returned to this office by the postal service with the indication that the envelope was "Refused." However, refusal to accept a mailed citation does not invalidate its issuance.

According to Section 24.106 of the Howard County Code, legal delivery of the citation may be accomplished by "posting the citation in a conspicuous place on the property where the violation exists or has occurred." The issued citation was posted on the door of the dwelling on your property at the above referenced address on February 11, 1998.

According to County records, as of the date of this letter, the fine indicated by the citation had not been paid and is ninety days overdue. Continued failure to pay the fine will result in scheduling of a hearing in District Court for Howard County.





Dear Mr. Shpak:

A Notice of Violation was mailed to you on September 26, 1996 and a Second Notice was mailed to you on November 19, 1997 reporting observations of an overflowing septic system and requiring connection to public sewerage as well as interim pumping of the septic tank with sufficient frequency to prevent additional discharges until connection is complete.

Your reply of November 24, 1997, does not sufficiently respond to the problem. Your letter alleges that the septic system is being effectively managed as a holding tank by regular pumping at sufficient frequency.

When public sewerage is available, use of a holding tank is not an acceptable option. According to the Code of Maryland Regulations (COMAR) 26.04.02.03 (B), "holding tanks may only be used to resolve existing on-site sewage disposal failures when community sewer facilities are not available or on-site repair is not possible. Therefore, continuing to maintain the existing holding tank situation for any additional extended period is in violation of COMAR. Continuing to maintain the holding tank is also inconsistent with the details of a discussion held on October 2, 1996, in which you advised me that connection to public sewer was being diligently pursued.

The justification for the COMAR regulation is sufficiently represented by this exact situation, in which discharges continue to occur due to the limited capacity of the septic tank and the unpredictability of sewage flow. Moreover, although you provide credible evidence of septic tank pumping on November 7, 1997, a sewage discharge was observed only ten days later. A 1000-gallon septic tank serving the occupancy level reported in this dwelling would be expected to reach capacity within one week of pumping. The discharge observed on November 17 would be well within expectations. For this same reason, pumping once every two months, on average (as reported by the receipts you submitted) is not sufficient to prevent additional discharges.

Although you provided a number of reliable septic tank pumping receipts, it is difficult to believe that sufficient pumping frequency has been or can be

achieved. The regulation appropriately reserves holding tanks for extremely limited situations in which no other solution is available. This is not the condition in this case, since you advised me more than one year ago that you own all the property between the dwelling and the Route 1 right-of-way.

In order to come to a timely conclusion to this matter, it is suggested that you call this office (410-313-2640) to schedule a meeting. Thank you for your attention to this matter.

Dear Mr. Shpak:

On September 26, 1996, this office issued an order to you pursuant to Howard County Code Section 12.105 to connect the above referenced property to public sewerage. Although the order remains in effect, no evidence of compliance has been observed or reported.

Follow-up inspections on October 30 and November 17, 1997 revealed surface sewage at the low end of the property approximately 30 feet beyond the septic tank cleanout. According to Howard County Code Section 24.106, each day between the above referenced dates of inspection inclusive is a separate offense.

The ongoing septic system failure creates a condition which continues to be a potential hazard to the public health. Although public sewerage connection remains the permanent solution, the more immediate concern is the failure to pump the septic tank with sufficient frequency to avoid sewage discharges.

You must immediately have the septic tank contents pumped by a licensed sewage scavenger. Until connection to the public sewer is complete, you must continue pumping as often as necessary to prevent future sewage discharges. Future discharges will be cause for issuance of more severe enforcement actions.

If you choose to appeal, you may file a written request with the executive secretary of the Board of Health within fifteen (15) days of receipt of this letter. If you wish to discuss the evidence, the regulations, or your individual circumstances, you are encouraged to request a meeting with us by calling (410) 313-2640 and scheduling an appointment.





NOTICE OF VIOLATION
7285 Washington Boulevard

Dear Mr. Choe:

On November 13, 1995, Kim Soe and I, sanitarians from this office, inspected your property known as Tax Map 43, Parcel 75, located at the above referenced address in response to a report of an overflowing septic system. On that occasion, we observed surface sewage at the low end of the property approximately 30 feet beyond the septic tank cleanout.

The limited repair previously authorized and completed on September 12, 1995 under permit number P50864 was not sufficient to prevent recurrence of the problem. The continuing septic system failure creates a condition which is, or may be, hazardous to the public health. Therefore, pursuant to Section 12.105 of the Howard County Code, you are hereby ordered to apply for the necessary permits for connection to the public sewer within thirty (30) days of receipt of this letter, and to make actual connection to the public sewer within sixty (60) days of receipt of this letter. After connection, the existing septic system must be properly abandoned (collapsed and backfilled).

You must immediately have the septic tank contents pumped by a licensed sewage scavenger. Until connection to the public sewer is complete, you must continue pumping as often as necessary to prevent future sewage overflows.

If you choose to appeal, you may file a written request with the executive secretary of the Board of Health within fifteen (15) days of receipt of this letter. If you wish to discuss the evidence, the regulations, or your individual circumstances, you are encouraged to request a meeting with us by calling 313-2640 and scheduling an appointment.

Failure to comply with this order may be grounds for court action. The investigation of this complaint and the enforcement powers of the Health Department are set forth in Section 12 of the Howard County Code, a copy of which is available for your review at this office.





Dear Sir:

Section 12.204 of the Howard County Code states: "The Board of Health, the County Health Officer, Sanitarian or his representative, shall take cognizance of all conditions dangerous to health and may on their own initative institute an investigation."

On Friday, July 23, 1971, the investigation revealed an overflowing sewage disposal system on your property located on Washington Boulevard opposite Meadow Ridge Cemetery, Elkridge, Maryland.

In my capacity, as a Sanitarian, with the Howard County Health Department, I have determined that this overflowing sewage is of such a condition that it creates a public nuisance which endangers the public health.

To abate this unhealthy nuisance you must connect the property to the public sewer which is available to your property.

You must comply with the provisions of this notice within thirty (30) days from the date of this notice, or apply to the Executive Secretary of the Board of Health for a hearing within ten (10) days from the date of this notice. If you do not apply for a hearing within the prescribed time and, if, you do not comply with this directive a summons will be issued directing you to appear before the District Court of Howard County for a trial.

I am enclosing an exact copy of the law and penalties that may apply in your case.

- 6/10/71 I contacted the Bureau of Water and Sewer who said public sewer might be available to this property in a few years.
- 6/11/71 I called S. Shpak. He said he would get someone to repair this septic system.
