

MEMORANDUM

- TO: File 1704 Woodstock Road
- FROM: Mark Rifkin Well and Septic Program

RE: Well Site Access

Site meeting with Alan Compton of Fogle's. He reports and inspection confirms access to well stake limited by severe soil saturation on the surface and ex. Colonial Pipeline not shown on perc. cert. Access through the lot restricted by requirements to protect drip disposal area from ruts/damage. Access via adjacent flagstem driveway limited by need to cross Pipeline twice, as well as soil moisture issues. He reports previous requests to cross Colonial Pipelines have generally not been successful in producing access.

He will contact Colonial Pipeline to determine if access possible, and contact client to determine next step. Review with B. Glotfelty indicates possible to allow well rig access to rear by running along right side boundary on extreme edge of drip disposal area, but conditions must be extremely dry before access should be provided.

Message left for Alan and property owner regarding above info.

Later T/C with owner indicates Fogle's backing out of job. She was advised of delay in drilling due to wetness if access is desired through property. She is also aware of Colonial Pipeline issues. I indicated preference for access via common driveway. Also reminded her of offsite options, esp. given neighbors' desire to remove abandoned house and associated trash.


