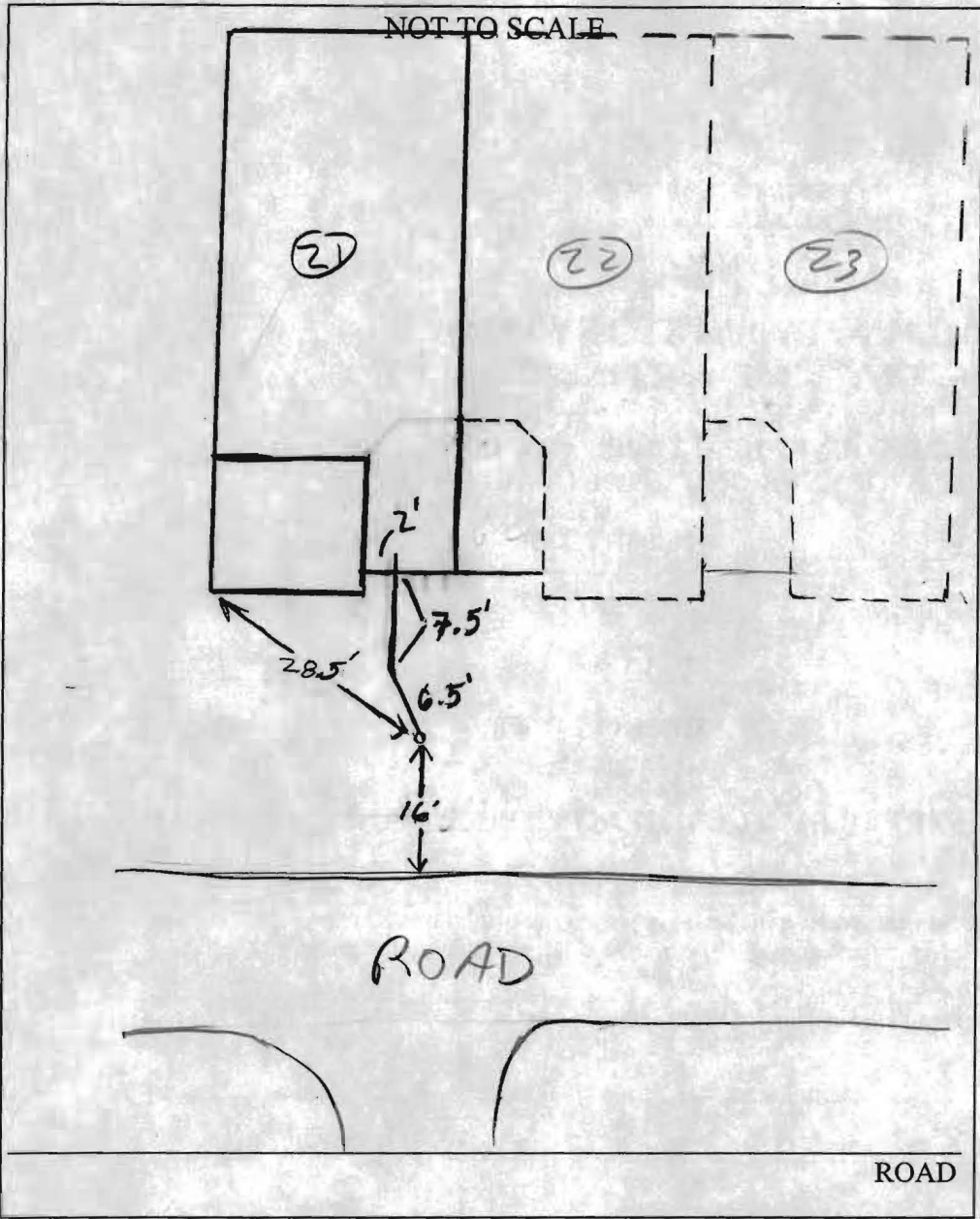


BEDROOM RESTRICTION ACKNOWLEDGMENT

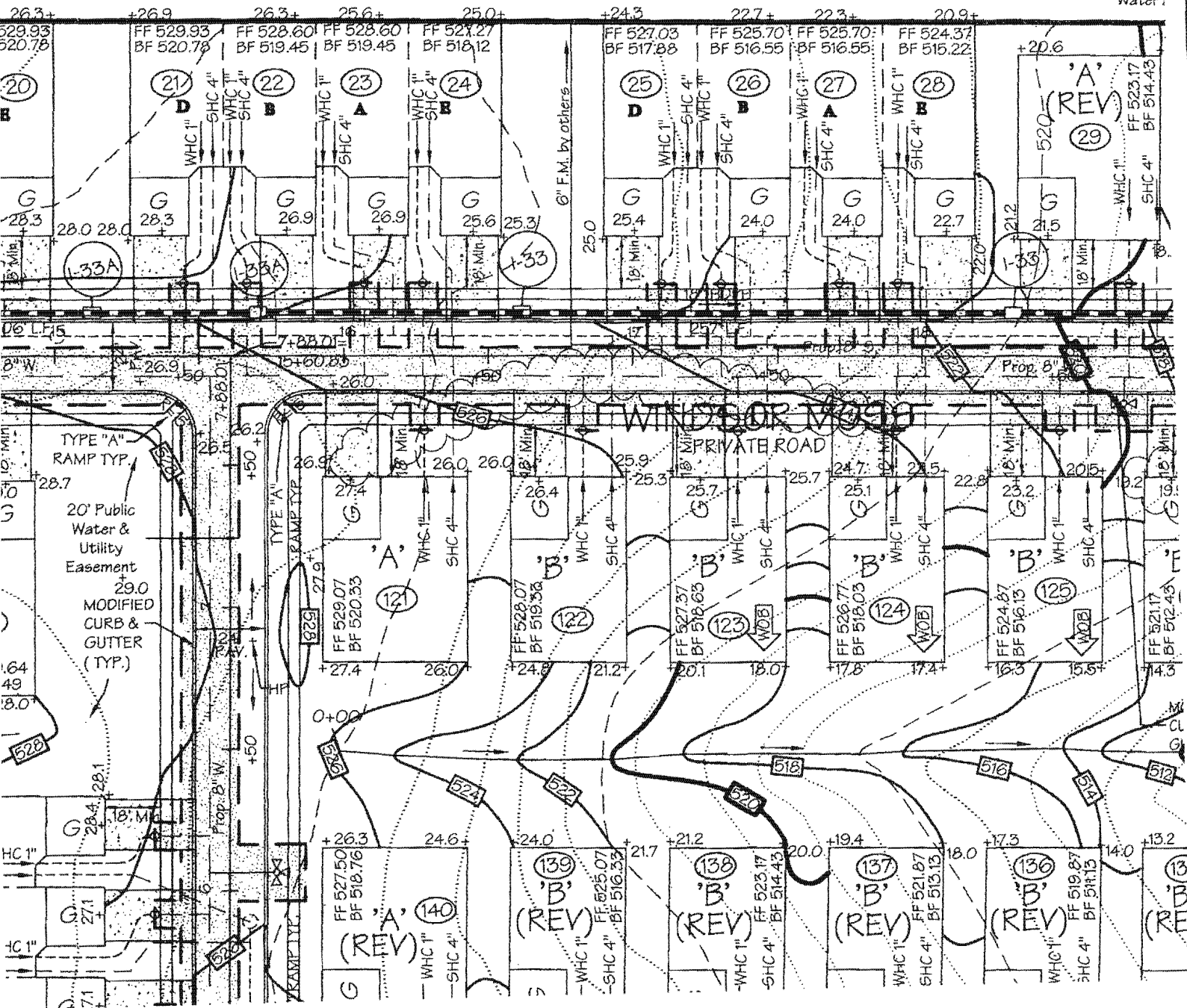
