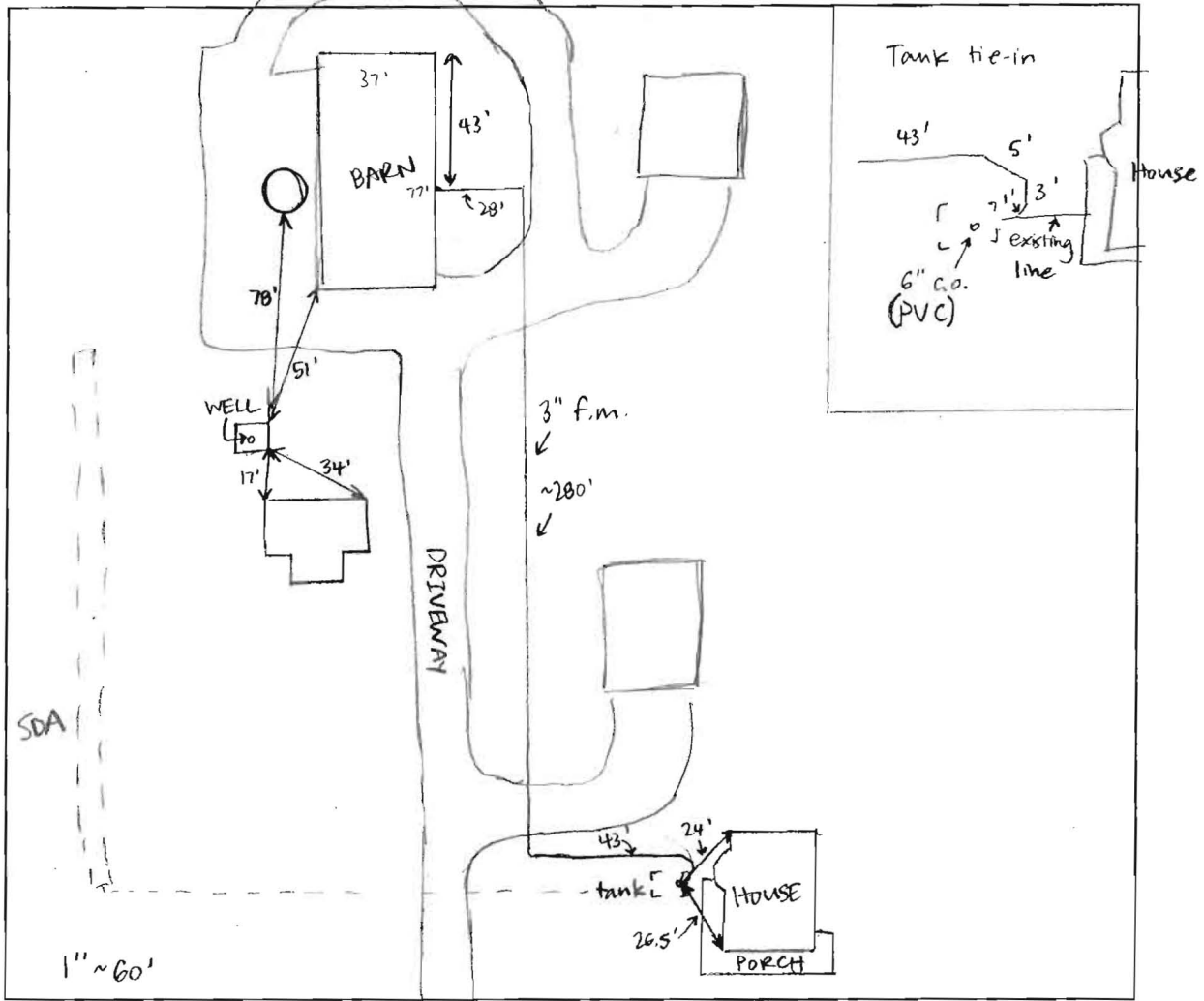

LOCATION DIAGRAM

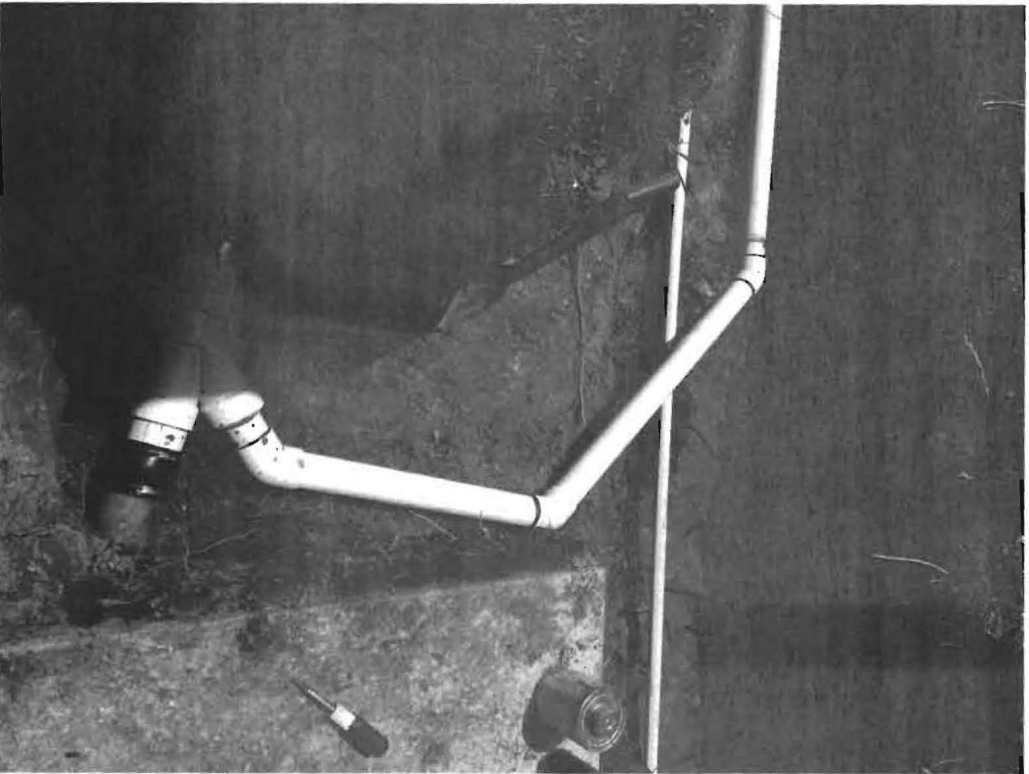

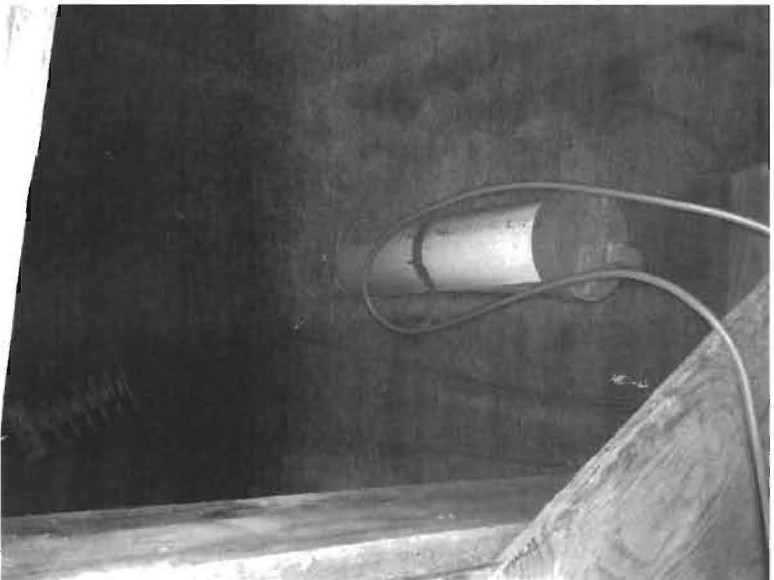

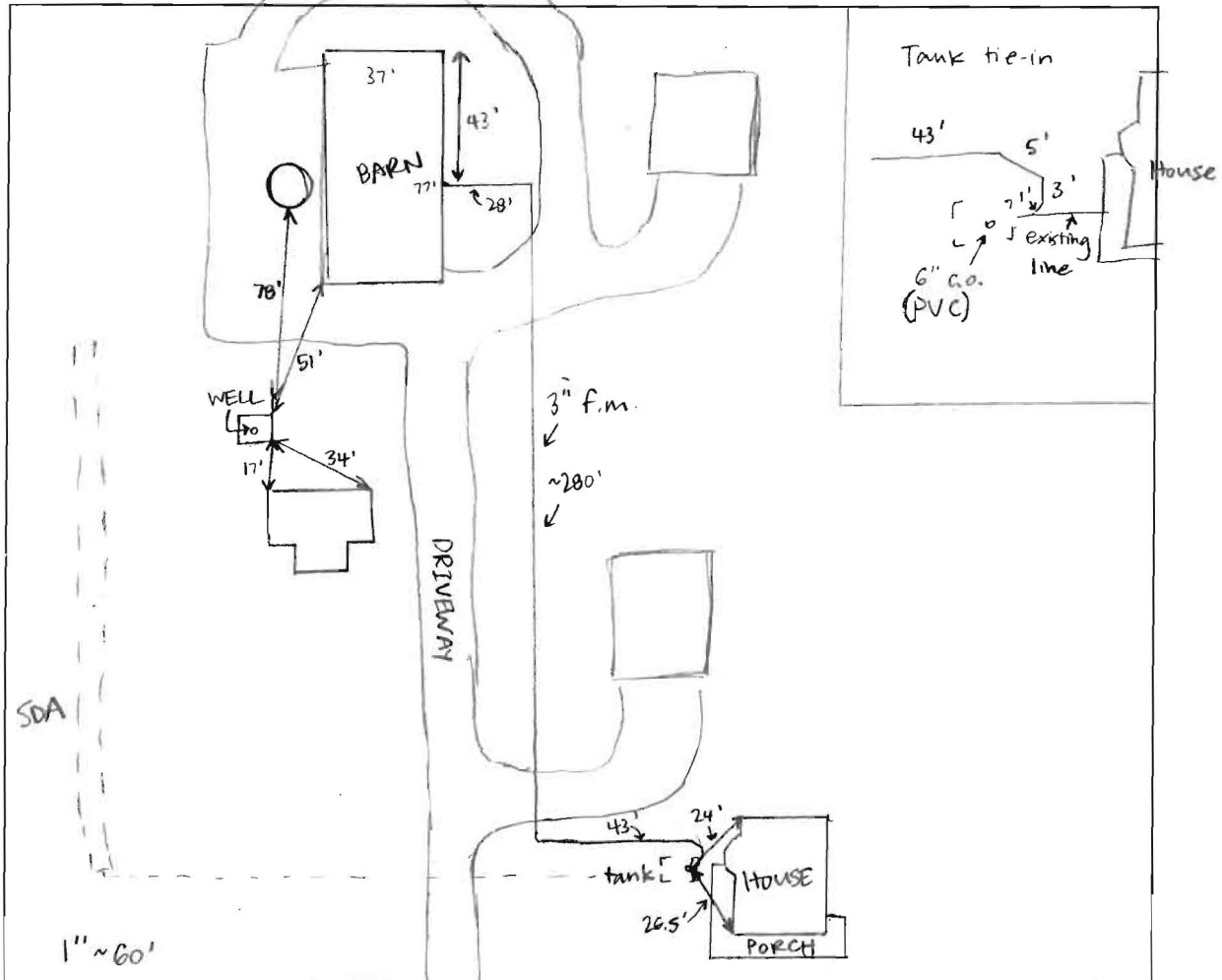
